## 5. FIREFIGHTING MEASURES

**5.1. Extinguishing media****Suitable extinguishing media**

As a result of combustion or thermal decomposition reactive sub-products are created that can become highly toxic and, consequently, can present a serious health risk.

**5.3. Advice for firefighters**

Depending on the magnitude of the fire it may be necessary to use full protective clothing and self contained breathing apparatus (SCBA). Minimum emergency facilities and equipment should be available (fire blankets, portable first aid kit). ## 6. ACCIDENTAL RELEASE MEASURES
